1. CALL TO ORDER

- Chairperson Vallarelli called the meeting to order at 3:06 p.m.

2. PLEDGE OF ALLEGIANCE

- Commissioner Iamonico led the Pledge of Allegiance.

3. NEW BUSINESS

- **RESOLUTION: Authorization of the Transfer of Funds from the Capital Reserve for Equipment Fund (Subject to Permissive Referendum)**
- **Motion:** A motion was made by Commissioner Muldoon, seconded by Commissioner Nanko, to adopt the following resolution:

WHEREAS, pursuant to General Municipal Law §6-g, the Hartsdale Fire District, Town of Greenburgh, County of Westchester, State of New York, maintains a Capital Reserve for Equipment Fund established for the purpose of financing the acquisition of firefighting equipment, including firefighting vehicles to be added to or replace vehicles within the existing fleet of the Hartsdale Fire District; and

WHEREAS, the Board of Fire Commissioners have previously approved, by resolution, that it is in the best interests of the Fire District to purchase one (1) 2026 Spartan Enforcer 2000 Gallon per Minute Pumper Truck to maintain and enhance fire protection services; and

WHEREAS, sufficient funds are available in the Capital Reserve for Equipment Fund for this purpose;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Fire Commissioners of the Hartsdale Fire District hereby authorizes the transfer of an amount not to exceed \$1,309,000.00 from the Capital Reserve for Equipment Fund into the General Fund for the purpose of purchasing one (1) 2026 Spartan Enforcer 2000 Gallon per Minute Pumper Truck and related expenses; and

BE IT FURTHER RESOLVED, that this resolution and this expenditure is subject to a permissive referendum in accordance with New York State law.

Upon roll call, the vote was as follows:

The resolution was adopted unanimously. This resolution is subject to permissive referendum and shall take effect thirty (30) days after adoption unless a valid petition is filed with the Secretary of the Hartsdale Fire District, 300 West Hartsdale Avenue, Hartsdale, New York 10530, within that time in accordance with applicable law.

4. ADJOURNMENT

- There being no further business for the Regular Meeting, a motion was made by Commissioner Iamónico, seconded by Commissioner Nanko, that the meeting be adjourned. All in favor. The motion carried.
