### SPECIAL MEETING MINUTES SEPTEMBER 11, 2025

A Special Meeting of the Board of Fire Commissioners of the Hartsdale Fire District was held at Fire Station 2, 300 West Hartsdale Avenue, Hartsdale, New York, on Thursday, September 11, 2025.

#### 1. CALL TO ORDER

- Chairperson Vallarelli called the meeting to order at 8:20 p.m.

- A motion was made by Commissioner Iamónico, seconded by Commissioner Muldoon, to approve the additional bills for the month of August 2025 in the amount of \$1,102.69, and to refer them to the Treasurer for payment. The motion carried.
